# AGREEMENT FOR ASSIGNMENT OF CERTIFICATES OF PURCHASE AT TAX SALE

The undersigned County of Hardin, State of Iowa, by authority of the Board of Supervisors of Hardin County, Iowa, hereinafter referred to as the "County"; and

Name of Offering Party, hereinafter referred to as "Dilley", hereby enter into the following agreement for the assignment of certain certificates of purchase at tax sale.

WHEREAS, the County is the owner of Certificate of Purchase of Tax Sale No. 15269-002 for parcel 881927155001 and Certificate of Purchase of Tax Sale No. 15268-001 for parcel 881928283002 of real property located in the City of Steamboat Rock, Hardin County, Iowa, described as:

ALL THAT PART OF LOTS 1, 2, AND 3 EXCEPT THE WEST 16 FEET OF SAID LOT 3, BLOCK 36, ORIGINAL TOWN, STEAMBOAT ROCK, HARDIN COUNTY, IOWA, LYING NORTH OF THE M. & ST. L. (NOW CHICAGO AND NORTHWESTERN TRANSPORTATION COMPANY) RAILROAD RIGHT-OF-WAY; AND ALL OF LOTS 3 AND 4, BLOCK 9, ROBINSONS ADDITION TO STEAMBOAT ROCK, HARDIN COUNTY, IOWA, LYING NORTH OF THE M. & ST. L. (NOW CHICAGO AND NORTHWESTERN TRANSPORTATION COMPANY) RAILROAD RIGHT-OF-WAY.

WHEREAS, the County acquired the aforementioned tax sale certificates as public bidder on the tax sale per Iowa Code section 446.19 and the County desires to assign said certificate to Dilley for the amount of \$3, 196.00, which reflects the principal amount of tax due of \$3,196.00 and the assignment fee of \$20.00 on the following conditions:

- 1. Said certificates may not be sold or assigned to a third party without prior written approval of the Board of Supervisors; and
- 2. In the event of a redemption by any party, all tax certifying bodies shall receive their proportionate interest; and

WHEREAS, the County agrees that should no party entitled by law to redeem said certificates in fact properly redeem said certificates and Dilley follows all statutory requirements for issuance of tax sale deed, the County Treasurer shall be authorized to issue said tax sale deed as contemplated by Chapters 447 and 448 of the Code of Iowa.

NOW THEREFORE, IT IS HEREBY AGREED that Hardin County shall and hereby does assign to Brandon Dilley the Certificate of Purchase at Tax Sale No. 15269-002 for parcel 881927155001 and Certificate of Purchase of Tax Sale No. 15268-001 for parcel 881928283002, the same to be signed by the Treasurer after receiving payment by Dilley of the sum of \$3,196.00, including the fee of \$20.00 as contemplated by Iowa Code section 446.31, provided that such assignment shall be without compromise as to the total amount due and provided further in the event of redemption by any party, all tax levying and certifying bodies having an interest in the funds represented by said Certificate of Purchase at Tax Sale No. 15269-002 for parcel 881927155001 and Certificate of Purchase of Tax Sale No. 15268-001 for parcel 881928283002 shall receive their proportionate share of any amount so received upon redemption.

#### AGREEMENT

THE AGREEMENT, made and entered into this \_\_\_\_\_\_ day of September, 2019, by and between Elaine Frerichs (hereinafter referred to as "Frerichs") and Hardin County, Iowa, (hereinafter referred to as "County").

#### WITNESSETH:

WHEREAS, the parties are in disagreement as to whether a roadway easement across a portion of Frerichs' property can be used as a public canoe access and for public recreation purposes or is necessary for road use purposes, and

WHEREAS, the parties are in agreement that an easement for access to the existing water hydrant is necessary for public safety, and

WHEREAS, the parties are in agreement that the approach to the water hydrant will require substantial rehabilitation, and

WHEREAS, the parties have reached an agreement in resolution of these issues:

In consideration of the terms and conditions as set forth herein the parties agree as follows:

- 1. The County will rehabilitate the approach area to the existing water hydrant, and Frerichs shall permit entry upon her land for such purpose, and Frerichs will not interfere with or frustrate the County rehabilitation efforts.
- 2. Upon completion of the County's rehabilitation of the approach area to the existing water hydrant, the County shall determine the dimension and legal description of an easement sufficient to provide the County and its designee(s) access to and maintenance and use of the water hydrant.
- 3. Once the County has determined the legal description required for the easement, the County will release to Frerichs all other portions of an existing easement no longer used for roadway purposes and not needed for the use and maintenance of the water hydrant the current easement particularly described as follows:

Commencing at the Northwest Corner of the Southwest One-quarter (SW1/4) of the Southeast One-quarter (SE1/4) of Section Twelve (12). Township Eighty-eight (88) North, Range Twenty (20) West of the 5<sup>th</sup> P.M., Hardin County, Iowa; thence East 752.1 feet; thence South 105.9 feet to the point of beginning; thence N77°27'W 226.1 feet; thence

S84° 415'40"E 69.1 feet; thence S87°07'E 100.1 feet; thence East 200.0 feet; thence N87°07'E 138.1 feet; thence S81°28'30'W 289.1 feet to the Point of Beginning.

- 4. This easement shall be personal to the County, and shall not run with the land, however, during the easement, the County shall be allowed to authorize other emergency organizations access to the water hydrant and approach area for maintenance and emergency use and all shall have the right to remove any obstacle, natural or otherwise, that hinders or impedes access to, and integrity of, the hydrant and approach.
- 5. Frerichs shall not block or obstruct or alter the approach or water hydrant without the County's written approval, and shall bear the cost of rehabilitation if she does.
- 6. The County shall not promote or encourage the site as a recreational access, and shall post signs to that effect both west and east of the existing bridge at the site.
- 7. The County shall post signage prohibiting parking on the gravel road within 300 feet to the west of the bridge adjacent to the site for safety and emergency access, and similar signage east of Frerichs' field entrance east of the bridge site at a point ultimately determined by the County.
- 8. Frerichs shall hold the County and the County designees harmless for the condition of the water hydrant and land subject of the easement.
- 9. The County shall have the right to abandon the easement at will.
- 10. By signing below, each of the undersigned attests to having authority to enter this agreement.

The parties hereto, their heirs, legal representatives, successors and assigns release the other party, its heirs, legal representative, successors and assigns from any and all liability, claims, demands, costs, charges and expenses relating to the public canoe or recreational access or purported public canoe and/or recreational access previously claimed by Hardin County along the south side of the bridge adjacent to and within Frerichs' real estate. This release covers all claims either party had, or have, or may have in the further, know or unknown against the other party, its heirs, legal representatives, successors or assigns based upon the foregoing dispute.

# Public Environmental Health/Planning and Zoning Administrator Agreement

This Contract and Agreement pursuant to Iowa Code Section 28E, is made and entered into this 20th day of August, 2019, by and between Marshall County, Iowa (hereinafter referred to as Marshall) and Hardin County, Iowa (hereinafter referred to as Hardin). This agreement shall be known as the Marshall-Hardin County Public Environmental Health/Planning and Zoning Administrator Agreement and each county shall adopt resolutions of this agreement. The Public Environmental Health/Planning and Zoning Administrator shall be (hereinafter referred to as Administrator). This agreement does not contemplate and shall not be construed to limit or expand the powers of the participating counties, except as expressly stated in the agreement.

The purpose of said agreement is to establish a working mechanism between the two participating counties so that the agencies may jointly utilize the services of the Hardin County Iowa Environmental Health and Zoning Administrator. Pursuant to said purpose it is agreed as follows:

- Marshall County does not currently employ a Public Environmental Health/ Planning and Zoning Administrator and shall contract with Hardin County for a period beginning July 15, 2019 and ending when Marshall County employs a Public Environmental Health/ Planning and Zoning Administrator.
- The Administrator shall have full control of all public environmental health, planning and zoning processes and permitting for Marshall County.
- Both Marshall and Hardin Counties desire and need the services of an Administrator to serve in these capacities in accordance with each county's code of ordinances.
- The Administrator shall devote his or her time and talents to the interests of both Marshall and Hardin counties.
- The Administrator shall file a bond suitable to each Board of Supervisors. All fees incurred by filing said bonds shall be paid by the respective counties.
- Marshall County shall carry workmen's compensation on the Administrator for injuries sustained while carrying out duties specific to Marshall County.
- Marshall County shall pay Hardin County \$30.00/hr. and mileage reimbursement at the current 2019 mileage rate for the duties of the Administrator.
- Marshall County shall timely notify Hardin County when a Marshall County Public Environmental Health/ Planning and Zoning Administrator has been hired and can start and perform the duties of Administrator.
- This agreement may be amended or revised at any time only by written approval of all parties involved.

- This agreement shall supersede all provisions of previous agreements and any such agreements presently existing shall become null and void.
- This agreement shall expire on October \$3, 2019, unless extended or otherwise amended in writing by all parties involved.

- Either County may terminate this agreement for any reason in written notice 30 days prior to termination.

The Administrator shall be in charge of the Public Environmental Health/ Planning and Zoning Department of each county. The Administrator may delegate duties to employees of the respective counties in consultation with the respective Board of Supervisors. The Administrator shall be indemnified and saved harmless by the respective county for any and all actions taken against said county, its Board of Supervisors or the Administrator, due to actions performed by the Administrator during the course of official duties for either county. Each county shall defend all such actions arising from that county and pay all judgements rendered in regards to the actions of the Administrator in that county. Each county shall acquire insurance as deemed necessary to accomplish the same.
