Chair Lance Granzow called the meeting to order. The meeting was held electronically due to COVID-19 public health risks. Also in attendance were Supervisors BJ Hoffman and Reneé McClellan; and Connie Mesch, Tifani Eisentrager, Becca Junker, Curt Groen, Pauline Lloyd, Allison Scott, Cheryl Lawrence, JD Holmes, Justin Ites, Rocky Reents, Julie Duhn, Abby Flatness, Angela De La Riva, Don Knoell, Donna Juber, Bob Juber, Denise Smith, Dave McDaniel, Mark Buschkamp, Thomas Craighton, Taylor Roll, Carey Callaway, Michael Pearce, Jessica Sheridan, Darrell Meyer, and Angela Silvey.

The Pledge of Allegiance was recited.

McClellan moved, Hoffman seconded to approve the agenda as posted. Motion carried.

Hoffman moved, McClellan seconded to approve the minutes of November 10, 2020 and the November 10, 2020 canvass. Motion carried.

McClellan moved, Hoffman seconded to approve the November 18, 2020 claims for payment. Motion carried.

Utility Permits: None.

Secondary Roads:

County Engineer Taylor Roll had no developments to report.

At 9:02 a.m. Chair Granzow opened the public hearing on a proposed road vacation of an easement of 170th Street. Roll reviewed the proposed vacation, requested by Elaine Frerichs. There being no oral or written comments or objections, McClellan moved, Hoffman seconded to close the public hearing. Roll Call Vote: “Ayes” McClellan, Hoffman, and Granzow. “Nays” None. Motion carried.

Hoffman moved, McClellan seconded that the following Resolution No. 2020-42, a resolution to vacate and quit claim to an easement of 170th Street, be adopted. Roll Call Vote: “Ayes” Hoffman, McClellan, and Granzow. “Nays” None. Resolution No. 2020-42 is hereby adopted as follows:

RESOLUTION No. 2020-42

WHEREAS, a public hearing was held at 9:02 A.M. on the 18th day of November, 2020 in the Conference Room of the Hardin County Board of Supervisors; and

WHEREAS, there being no objections to the vacating of part of the Hardin County road right-of-way as advertised; and

WHEREAS, there being no claim for damages.

NOW THEREFORE BE IT RESOLVED by the Hardin County Board of Supervisors that the subject section be ordered vacated and closed and denies any and all claims for damages.

Hardin County Quit Claims its interest to the following property owner:

Elaine J. Frerichs - An easement being a part of an existing road right of way easement of 170th Street located in the Fractional West One-half (FrW ½) and the West Five Rods (W. 5 Rods) of the Northeast Quarter (NE ¼) all in Section Seven (7), Township Eighty-eight (88) North, Range Nineteen (19) West of the 5th P.M., Hardin County, Iowa, more particularly described as follows:

Commencing at the West Quarter (W ¼) Corner of said Section 7; thence South 89°37'53" East, 924.16 feet along the existing centerline of 170th Street to an intersection of said centerline with a

line offset 66.00 feet Southerly from the north line of the Hardin County Frerichs Easement Project (said intersection being the point of beginning); thence North 82°23'00" East, 1467.16 feet along a line parallel and 66.00 feet offset Southerly from said north line; thence South 87°48'58" East, 96.53 feet along said parallel line to a point on the east line of said West Five Rods (said point also being a point on a curve on the southern existing right of way line of said 170th Street); thence southwesterly 350.25 feet on said southern right of way line along an 883.73 feet radius curve, concave Southeasterly, having a central angle of 22°42'29" to a corner thereof; thence South 69°03'20" West, 99.16 feet along said southern right of way line to a corner thereof; thence Southwesterly 179.67 feet on said southern right of way line along a 707.69 feet radius curve, concave Northwesterly, having a central angle of 14°32'47" to a corner thereof; thence South 83°36'07" West, 798.98 feet along said southern right of way line to a corner thereof; thence North 89°37'53" West, 382.32 feet along said southern right of way line to the intersection of said southern right of way line and with said parallel line; thence North 82°23'00" East, 237.55 feet along said parallel line to the point of beginning, containing 1.78 acres total. Subject to easements.

For the purpose of this survey, the south line of the Fractional Northwest Quarter (FrNW ¼) was determined to bear South 89°33'15" East using GPS.

WHEREAS, the Hardin County Board of Supervisors adopted on or about April 1, 2020, an Infectious Disease Action Plan, Resolution 2020-15; and

WHEREAS, the Hardin County Board of Supervisors adopted on August 12, 2020, a policy regulating entry by county employees and the public to the County Courthouse, County Office Building and County Jail/Sheriff Office; and

WHEREAS, the Hardin County Board of Health adopted on or about August 27, 2020, a recommendation that face coverings be worn by all in public; and

WHEREAS, the Hardin County Board of Supervisors remains actively involved in response to the ongoing COVID-19 pandemic and is committed to protecting the health of Hardin County employees and the public; and,

WHEREAS, the Center for Disease Control and Prevention, the Hardin County Public Health Department and the Governor of the State of Iowa recommend face coverings to prevent the spread of COVID-19; and

WHEREAS, Hardin County encourages political subdivisions and private businesses throughout Hardin County to explore similar measures to reduce the spread of COVID-19 and help keep businesses operational; and

WHEREAS, the Hardin County Board of Supervisors has jurisdiction over Hardin County facilities and property;

NOW, THEREFORE BE IT RESOLVED that Hardin County hereby amends Resolution No. 2020-15, to include the attached provision requiring the use of face coverings by all Hardin County employees and visitors to Hardin County property.

AMENDMENT TO RESOLUTION NO. 2020-15

All Hardin County employees when not at their respective workstation shall always wear face coverings (defined by the Hardin County Board of Health as “a material that securely covers a person’s nose and mouth and remains affixed in place without the use of one’s hands, whether purchased or homemade, and consistent with CDC guidelines”). If an employee is not medically able to wear face covering such as a mask, then a face shield that meets CDC guidelines may be worn. It will be the employee’s burden to demonstrate a medical inability to wear a face covering such as a mask. All employees will limit contact with multiple people in a workspace. This includes regular workstations, break rooms and other collective spaces.

The county building entry policy adopted on August 12, 2020, as amended, is incorporated herein by the reference.

Face coverings are required of visitors to all county owned buildings in addition to any other policies in effect.

Employees are encouraged to wear facial covering outside of work environment while in public.

Employees experiencing any symptoms described in Resolution No. 2020-15 shall report it immediately. Employees shall call their supervisor to

report these conditions. The Supervisor/Department Head shall relay this information to the County Auditor's Office immediately.

Emergency Management Update:

Emergency Management Coordinator Thomas Craighton reported on an outbreak at the Jail which has been contained and a new process for PPE distribution.

Public Comments:

Donna Juber commented on COVID-19 spread prevention.

Questions and comments were received from Pauline Lloyd.

Julie Duhn thanked the Board for adopting a mask requirement.

Other Business: None.

McClellan moved, Hoffman seconded to adjourn. Motion carried.

At 1:30 p.m. the Board met for a department heads/elected officials meeting. The meeting was held electronically due to COVID-19 public health risks. In attendance were Supervisors Granzow, Hoffman, and McClellan; and Matt Jones, Thomas Craighton, Rocky Reents, Becca Junker, Dave McDaniel, Linn Adams, Machel Eichmeier, Wes Wiese, Darrell Meyer, Taylor Roll, Jessica Sheridan, Jody Mesch, and Angela Silvey.

Matt Jones, IT Director, addressed internet connectivity issues caused by employees logging onto Board meetings from their work computers.

Jones also announced that the County's phone system will reach its end of life October 1, 2021, and he and Network Specialist Michael Pearce are exploring options to present to the Board.

Discussion was held on COVID protocols adopted earlier that day by Resolution No. 2020-43, specifically employee symptom reporting procedures and employee mask requirements.

Questions were posed regarding when an employee qualifies for COVID leave versus sick leave. County Attorney Darrell Meyer reviewed the provisions of the COVID-19 Response Policy adopted April 1, 2020.

Other Business:

Linn Adams advised the Friendship Club received a grant to replace its bus and asked if the County wanted the bus returned. The Board agreed the bus was the Friendship Club's to sell.

Wes Wiese wondered when department heads could expect to receive budget planning sheets.

1. LOCATION PLAN
An applicant shall file a completed location plan as an attachment to this Utility Permit Application.

2. WRITTEN NOTICE
At least five (5) working days prior to the proposed installation, an applicant shall file with the County Engineer a written notice stating the time, date, location, and nature of the proposed installation.

3. INSPECTION
The County Engineer may provide a full-time inspector during the installation of all lines to ensure compliance with this Utility Permit.

4. INSPECTION FEES
The applicant shall pay actual costs directly attributable to the installation inspection conducted by the County Engineer.

5. REQUIREMENTS
The installation inspector shall assure that the following requirements have been met:

- A. Construction signing shall comply with the Manual on Uniform Traffic Control Devices
B. Depth - (Add additional depth if ditch has silted to the thickness of the deposited silt.) The minimum depth of cover shall be as follows:
Telecommunications.... 36" Electric.....48"
Gas.....48" Water.....60"
Sewer.....60"
C. Minimum roadway overhead clearance for utility lines shall be 20 feet.
D. The applicant shall use reference markers in the right-of-way (ROW) boundary to locate line and changes in alignment as required by the County Engineer.
E. All tile line locations shall be marked with references located in the ROW line.
F. No underground utility lines shall cross over a crossroad drainage structure without approval from the County Engineer.
G. Residents along the utility route shall have uninterrupted access to the public roads.
H. After construction, granular surfacing shall be added to the road by the applicant to restore the road to its original condition.
I. All damaged areas within the ROW shall be repaired and restored to at least their former condition by the applicant.
J. Areas disturbed during construction which present an erosion problem shall be solved by the applicant in a manner approved by the County Engineer.
K. All trenches, excavations, and utilities that are knifed shall be properly tamped.
L. All utilities shall be located between the bottom of the backslope and the bottom of the foreslope, unless otherwise approved in writing by the County Engineer prior to installation.
M. Road crossing shall be bored. The depth below the road surface shall match the minimum depth of cover for the respective utility.

6. NON-CONFORMING WORK

The County Engineer may halt the installation at any time if the applicant's work does not meet the requirements set forth in this Utility Permit Application.

7. COUNTY INFRACTION

Violation of this permit is a county infraction under Iowa Code Section 331.307, punishable by a civil penalty of \$100 for each violation. Each day that a violation occurs or is permitted to exist by the applicant constitutes a separate offense.

8. HOLD HARMLESS

The utility company shall save this county harmless of any damages resulting from the applicant's operations. A copy of a certificate of insurance naming this county as an additional insured for the permit work shall be filed in the County Engineer's Office prior to installation. The minimum limits of liability under the insurance policy shall be \$1,000,000.

9. PERMIT REQUIRED

No applicant shall install any lines unless such applicant has obtained a Utility Permit from the County Engineer and has agreed in writing that said installation will comply with all ordinances and requirements of the county for such work. Applicants agree to hold the county free from liability for all damage to applicant's property which occurs proximately as a result of the applicant's failure to comply with said ordinances or requirements.

10. RELOCATION

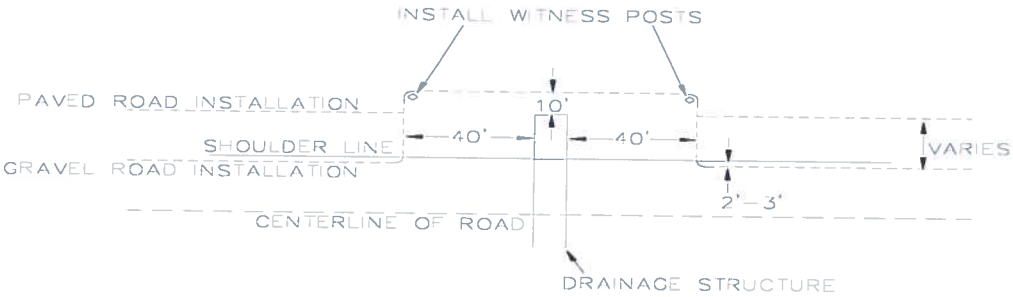

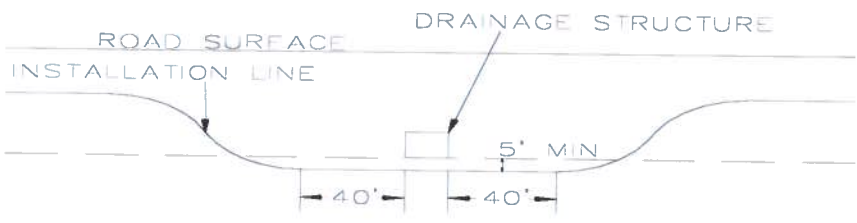

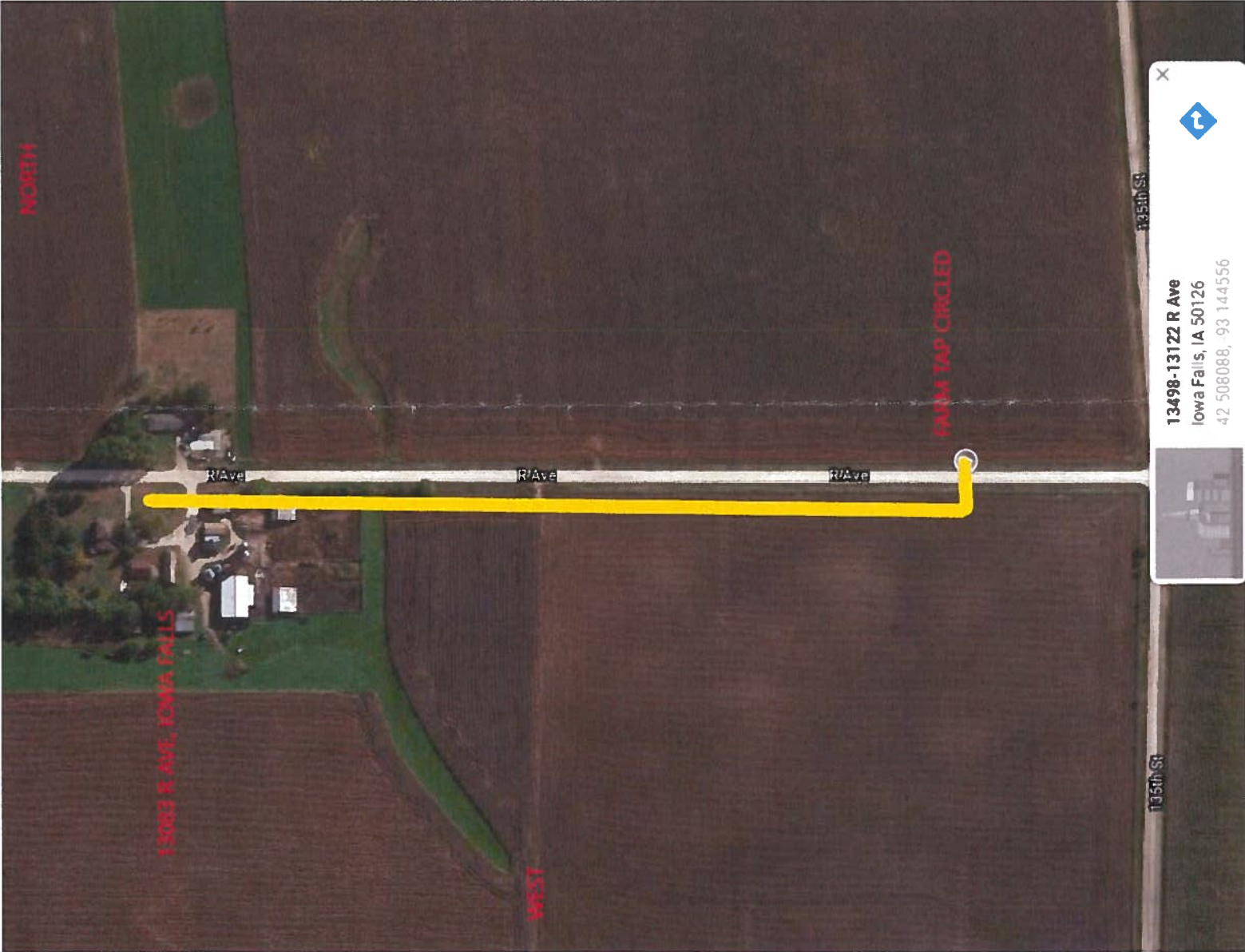
