Chair BJ Hoffman called the meeting to order. Granzow moved, McClellan seconded to approve the agenda as posted. Motion carried.

McClellan moved, Granzow seconded to approve the October 27, 2021 claims for payment. Motion carried.

IFADC Update:

Mark Buschkamp, Executive Director, reported on business prospects, development projects, grants sought, and other IFADC activities.

A departmental update was provided by Taylor Roll. No action was necessary; informational only.

McClellan moved, Granzow seconded to approve the bridge inspection and rating program for 2022 and 2023 with Calhoun-Burns & Associates. Motion carried.

Granzow moved, McClellan seconded to approve the Application for Use of Courthouse Grounds submitted by the Eldora Public Library for a Story Walk slated for November 23-30, 2021. Motion carried.

WHEREUPON Board Member Granzow moved that the following Resolution be adopted:

## **RESOLUTION 2021-44 COMPENSATION OF MEMBERS OF ELECTION BOARDS**

WHEREAS, Iowa Code §49.20 authorizes the county board of supervisors to establish the compensation of members of election boards, and

WHEREAS, the Hardin County Board of Supervisors has not reviewed or otherwise considered the compensation paid to members of election boards in several years, and

WHEREAS, changes in Iowa's elections laws since 2016 have required members of the election boards to adapt to new election laws and technologies, and an ever-increasing focus on procedures and security create additional challenges with finding new members, and

WHEREAS, it is vital to the Hardin County elections process to build and maintain a strong pool of election board members, and an increase in compensation would certainly help with the recruitment of new members, as well as the retention of those who have faithfully served over the years;

NOW, THEREFORE BE IT RESOLVED that the Hardin County Board of Supervisors hereby authorizes that, effective November 2, 2021, the hourly compensation of election board members shall be \$10.00 per hour, with an additional \$1.00 per hour if the member serves as co/chair of a precinct on election day.

The motion was seconded by Board Member McClellan and after due Consideration thereof, the roll was called and the following Board Members voted:

Following discussion, McClellan moved, Granzow seconded to exit closed session. Motion carried. Closed session ended at 10:58 a.m.

McClellan moved, Granzow seconded to recess. Motion carried.

At 11:28 a.m. the Board met for the employee performance review of Jessica Sheridan, Environmental Health Director/Sanitarian and Zoning Administrator. Present: Supervisors Hoffman, McClellan, and Granzow; and Sheridan.

Sheridan requested to go into closed session pursuant to Iowa Code 21.5(1)(i). Roll Call Vote: "Ayes" Granzow, McClellan, and Hoffman. "Nays" None. Motion carried. The Board entered closed session at 11:28 a.m.

Following discussion, Granzow moved, McClellan seconded to exit closed session. Motion carried. Closed session ended at 12:04 p.m.

At 1:00 p.m. the Board met for a budget amendment and American Rescue Plan work session. Budget information and worksheets were handed out to department heads. It was noted that budget amendments and remaining appropriations for FY 2021/2022 will take place in December.

Discussion turned to ARPA funds, \$3.2 million of which is earmarked for Hardin County. Items proposed and discussed for utilization of ARPA funds include:
