HARDIN COUNTY BOARD OF SUPERVISORS MINUTES – NOVEMBER 20, 2024 WEDNESDAY – 9:00 A.M. HARDIN COUNTY COURTHOUSE LARGE CONFERENCE ROOM

The Hardin County Board of Supervisors held their regular meeting at 9:00 AM on November 20, 2024, at the Hardin County Courthouse large conference room in Eldora, Iowa.

Board members in attendance were Lance Granzow, BJ Hoffman, and Renee McClellan. Also attending: Ann Larson, Taylor Roll, Jolene Pieters, Machel Eichmeier, Deb Crosser, Bri Amling, Elaine Loring-Jass, Donna Juber, and Julie Duhn.

McClellan moved and Hoffman seconded the motion to approve the agenda. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to approve the minutes of November 13, 2024. All Ayes. Motion carried.

McClellan moved and Hoffman seconded the motion to approve claims for payment for November 20, 2024. All Ayes. Motion carried.

McClellan moved and Hoffman seconded the motion to order a recount of Public Measure IQ for the AGWSR School as requested by the school. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to approve Resolution 2024-37, ordering a recount of votes in the precincts in Hardin County which are in the AGWSR school district. Discussion: Pieters stated that this measure had to pass by 60%. Pieters stated that there were four counties involved. WHEREAS, Erik Smith, Superintendent of AGWSR Schools, properly filed a request for a recount of votes in the AGWSR School District precincts for Public Measure IQ in Grundy County, the control County for the AGWSR School District as prescribed by Code of Iowa §50.48(1); §50.49(1).
