**Approval of Minutes:** Sandy Trampe made the motion to approve the minutes of the August 13, 2019 Regular Monthly Board Meeting and the minutes of the September 3, 2019 Special Meeting-Closed Session. It was seconded by Jessica Lara. All members voted aye; the motion carried.

**Approval of Claims:** Jessica Lara made the motion to approve the September 9, 2019 monthly claims. It was seconded by Sandy Trampe. All members voted aye; the motion carried.

## **General Business**

**Brekke Memorial Park/Water Service:** Director Wes Wiese informed the Board of his conversation with Dan Brekke on the issue of water usage at Brekke Memorial Park. It was discovered that there was a leak in the waterline. The Brekke Family will have the waterline repaired and requested that the Board take-over paying the monthly water fee from Iowa Regional Utilities Association (IRUA). Sandy Trampe made a motion to approve the request from the Brekke Family and it was seconded by Jessica Lara. All members voted aye; and the motion carried.

**Calkins Nature Area/Waterline:** The Friends of Calkins have committed \$3,500.00 for a new waterline from the well to the new building at Calkins Nature Area. The Friends have asked the Board to contribute to the project. Trenching the waterline will cost \$5,070.00 or Boring the waterline will cost \$6,475.00. Sandy Trampe made a motion to approve the trenching of the new waterline at Calkins Nature Area with HCCB's contribution of \$1,570.00. This was seconded by Jessica Lara. All members voted aye and the motion carried.

**Leverton Timber/Gate:** Jessica Lara made a motion to approve the purchase of a gate for the entrance to Leverton Timber and it was seconded by Sandy Trampe. All members voted aye; and the motion carried.

**Sac/Fox Overlook:** Jessica Lara made a motion to approve a rental fee of \$250.00-perday for renting the Sac/Fox Overlook shelter (any event already scheduled is grand-fathered in) and it was seconded by Sandy Trampe. All members voted aye; and the motion carried.

**Other Items:** The Board and Director discussed items for an up-coming Strategic Planning Meeting. All was information only and no motion was necessary.
