DD 143 – McClellan moved, Rickels seconded to approve the contract with McDowell & Sons Contractors, Inc. in the amount of \$198,775.00 with completion date by November 15, 2016 and a start date no earlier than September 1, 2016. All ayes. Motion carried.

DD 1 – The Trustees agreed to table any action regarding the televising results from Work Order #152 until the hearing on September 14, 2016. Televising showed mud, rock and silt in the tile are causing flow in the tile to be restricted and stopped. This tile runs in the road ditch, parallel with the road. The Trustees asked Schlemme to obtain legal input if this repair would be secondary roads or the drainage district expense.

Other Business:

DD 102 – Schlemme updated the Trustees that Drainage Attorney, Mike Smith, responded that it is not the drainage district's responsibility to build a bridge or culvert to cross an open ditch, but rather the landowner be compensated for the "severance" of his land as part of the assessment that takes place. The landowner can use part of the damages assessed to pay for the bridge. This legal opinion will be discussed in more detail at the hearing to take place at 11:30 a.m.
