DD 55 Division 3 Lateral 9 – Rickels moved, McClellan seconded for Smith to correspond with Attorney, Bob Goodwin, regarding the 1944 Mutual Drainage District. Gallentine stated there does not appear to be any benefit this district is receiving from DD 55 Division 3, as they are only connected to the tile going south to the creek. Smith believes the fair approach is to allow the mutual district to proceed with their classification. This would require the DD 55 Division 3 Lateral 9 and DD 55 Division 3 as a whole to be reclassified with these landowners excluded. The 1944 Mutual District will need to be classified as well. Smith stated that it appears from the original records that the intent was to be their own drainage district. Smith will correspond with Goodwin to see if they would like to move forward with the procedures necessary to officially create this separate district. All ayes. Motion carried.
