McClellan moved, Hoffman seconded to approve the agenda as presented. All ayes. Motion carried.

Hoffman moved, Granzow seconded to approve the minutes of the April 12, 2017 regular drainage meeting. Ayes: Hoffman, Granzow. Abstain: McClellan. Motion carried.

DD 1 – Hoffman moved, Granzow seconded to approve the minutes of the April 12, 2017 landowner meeting. Ayes: Hoffman, Granzow. Abstain: McClellan. Motion carried.

McClellan moved, Hoffman seconded to approve the Hamilton County joint drainage district assessments. All ayes. Motion carried.

- DD 1 Hoffman moved, McClellan seconded to approve Gehrke Inc. Contractor's Qualification Statement and for Ryken Engineering to move forward with contracts. All ayes. Motion carried.
- DD 31 The Trustees agreed that Work Order #175 should be taken out to the lottery system to assign a contractor. The previous motion made on April 5, 2017 stated that if Hands On could not perform the repair in a week that it should go into the lottery system.
- DD 167 McClellan moved, Hoffman seconded to approve Work Order Request #177 for a blowout in Section 4 of Providence Township and for Ryken to verify that it is Drainage District tile. All ayes. Motion carried.
- DD 14 McClellan moved, Hoffman seconded to approve Work Order Request #179 for a blowout and cracked tile as seen in televising footage in Section 34 of Buckeye Township. Ryken Engineering is to review the televising footage and report back to the Trustees. All ayes. Motion carried.
- DD 95 The Trustees agreed that Work Order Request #180 should be voided and added to Work Order #162 as that request has not been completed yet and they are more than likely the same blowout.

Other Business:

- DD 144 Hoffman moved, McClellan seconded to create a work order from Martin Broer for flooding problems in Section 10 of Ellis Township on the north side of the intersection of KK Ave and 180th St. It was believed this was a secondary roads problem, but the Trustees feel the drainage engineer should also investigate. Schlemme is to add it to next week's agenda. All ayes. Motion carried.
- DD 143 Gallentine updated the Trustees that McDowell & Sons has been communicating daily with him that the weather is not cooperating to complete the repair at the golf course location.
- DD 123 It was discussed that the attorney, Mike Richards, stated his opinion that if Central Iowa Water Association is moving into drainage districts without permits, a cease and desist letter should be sent demanding they apply for and receive easements. The Trustees agreed that Schlemme should email the attorney update to Gallentine and to contact the water association first before asking Richards to produce a cease and desist letter.

It was also discussed that Windstream is laying cable in the county. The Trustees agreed that Schlemme should contact Windstream to discuss easement/permits be applied for.

DD 10 & DD 11 – It was discussed that the beaver dam has disappeared in the area and Robert Smuck is working on the removing the beavers. They are still there but due to homeowner dogs on the premises, he has not been able to set any traps. The Trustees agreed Gallentine should arrange for rodent guards be installed at the outlets and Schlemme should void the beaver dam work order.

DD 55-3 Lat 9, 9A & 9C – Gallentine had signed contracts available for Trustee signatures.

DD 72 – Gallentine presented the Supplement to Engineer's Report to be discussed at the April 26, 2017 continuance of hearing.

Schlemme presented the Trustees with Ryken Engineering's new 2017 Rate Schedule effective May 1, 2017. It was discussed that rates have not been adjusted since 2012. The Trustees acknowledged receipt.
