DD 55-3 Lat 9, 9A and 9C – Hoffman moved, Granzow seconded to approve the Engineer's Specifications for Outlet Repairs to Lateral 9A and Improvements to Laterals 9 and 9C dated January 23, 2017 and to set the bid letting date as Wednesday, February 22, 2017 at 11:30 a.m. in the large conference room in the lower level of the Hardin County Courthouse. DD 55-3 Lat 9 – Landowner, Scott Thompson, presented a request to allow the open ditch through his property in Section 1 of Concord Township be converted to a pond. Gallentine stated his main concerns would be responsibility of long term maintenance of the pond and the water level in regards to the outflow which goes into a tile under the road. After much discussion, it was determined that Thompson should contact Drainage Attorney, Mike Smith, to verify the legality of converting a drainage facility into a pond. Thompson is also to compile a rough draft of his plans to present at a landowner's meeting.

DD 55-3 Lat 9 – Hoffman moved, Granzow seconded to schedule a landowner's meeting for Wednesday, February 22, 2017 at 12:15 p.m. in the large conference room in the lower level of the Hardin County Courthouse to discuss the request of Scott Thompson's pond. All ayes. Motion carried.

## Other Business:

DD 34 – Schlemme advised the Trustees of a potential hog building to be built in the NE SW of Section 20-26-22. There are district tiles that run in that section and the owners are asking if the tile can be rerouted. The Trustees agreed the landowners can request an official approval from the district and then work with Drainage Engineer, Lee Gallentine, to observe and ensure the tile is installed at district standards. An official contract/agreement would need established as well.

DD 62 – Schlemme requested an update in regards to the Owasa Finisher site and the rerouting concern of district facilities. Granzow stated it is still in the hands of the DNR. It was discussed that Schlemme could contact DNR representative, Paul Pettiti, for an update.
