DD Big 4 Main – Hoffman moved, McClellan seconded to approve Work Order Request #190 for banks washed out in Section 5 of Buckeye Township. Ryken is to investigate. All ayes. Motion carried.

DD 102 – Hoffman moved, McClellan seconded to approve fine grading and seeding as stated in #1 of the Repair Summary Additional Actions Recommended for Work Order #184. Also to acknowledge the crop damage as stated in #2 and to evaluate if needed in the future as stated in #3. All ayes. Motion carried.

Schlemme updated the Trustees that Attorney, Mike Richards, had stated that until there is officially a reclassification, the charges incurred should be assessed per the old schedule. It was discussed that landowners have requested a project move forward right away and a reclassification to occur at some point for that project. It was questioned if that terminology existed at the beginning of the project, if the costs could be assessed to the new assessment. The Trustees agreed that Schlemme should receive further clarification.

## Other Business:

DD 123 – Gallentine updated the Trustees that they have televised the tile but the broken down planter is still located on top of the tile. He has spoken with the landowner who stated they are trying to get parts for it. The Trustees agreed that Gallentine should review the televising video first and report back what actions will be needed. Hopefully in the meantime, the planter will be fixed and removed.

DD 86 – Gallentine explained that the time frame is up in regards to the letter sent to the landowner regarding the tree removal and he has not received any response. The Trustees agreed to move forward with the contractor to remove the tree.
