## Other Business:

DD 48 – The Trustees agreed that the requested new surface drain approximately 500 feet from the reported eroded outlet should be installed as part of the Work Order #151 project at district cost.

DD 143 – Gallentine updated the Trustees that televising is completed through the town of Radcliffe and the repair summary will be submitted soon. It was discussed that the golf course project is complete except for leveling of dirt. Once that is finalized this spring, a completion hearing will result.

Schlemme updated the Trustees that she is working on drainage assessments and will have almost 90 districts to assess this year. Most of them are for the map scanning that occurred in 2016.
