REGULAR DRAINAGE MEETING

9/27/2019 - Minutes

1. Open Meeting

Hardin County Board of Supervisors Chairperson, Renee McClellan, opened the meeting. Also present was Supervisor, BJ Hoffman; Landowner Dennis Prochaska; Steve McDowell with McDowell & Sons; Contractor, Adam Seward; Lee Gallentine with Clapsaddle-Garber Associates (CGA); Drainage Clerk, Becca Junker. Lance Granzow was present via phone.

2. Approve Agenda

Hoffman moved, Granzow seconded to approve the agenda as presented. All ayes. Motion carried.

3. Approve Minutes

Hoffman moved, Granzow seconded to approve the minutes of the August 27, 2019 regular drainage meeting, September 4, 2019 regular drainage meeting, September 11 regular drainage meeting, September 18, 2019 regular drainage meeting. All ayes. Motion carried.

4. DD 9 - Discuss, With Possible Action, District Tile In Railroad Right Of Way

Junker explained that George loger came in on Monday and was asking if the district tile in the North that is in the railroad right of way could be moved out of the right of way. Gallentine explained it looked like a rough guess of 600 ft in the railroad right of way and all in Roberts ground. Granzow asked if there was a purpose to moving the tile, if it was plugged or if something was wrong with the tile. Junker explained there was nothing reported wrong with the tile. Granzow explained that until there becomes an issue, there is no reason to move this tile. He continued that although loger is trying to be proactive, there is no reason to add this cost at this time. No motion.

5. DD 167 - Discuss, With Possible Action, Repair Summary For Work Order 260

Gallentine explained that after CGA investigated they found several sinkhole blow outs, a part of the main that had been crushed by machinery, and an approximately 100-feet section of tile that was missing with significant erosion taking place in the assumed tile route at the Main tile outlet. Also found large mulberry trees in close proximity to some of the blowouts/sinkholes on the Main tile.

The recommendation is to replace the missing 100-feet of Main tile including the outlet and reinstall the eroded soil along said approximate 100-feet stretch. Remove all trees and brush within 50-feet of the main tile and excavate and repair the Main tile blowouts/sinkholes as necessary. The estimated cost of that is \$15,000 - \$20,000 if there is not a headwall put in at the outlet. If a headwall is deemed necessary, it is estimated that \$20,000 - \$25,000 will be added to the construction cost. He did explain that the missing 100-feet is flowing but if nothing is done the field will continue to have erosion.

Granzow moved, Hoffman seconded to upscale to a larger tile for the 100-feet with no headwall. Hoffman said that CGA will take this to the lottery system and suggested splitting between a contractor for the tile and Adam Seward to remove the trees. All ayes. Motion approved.

6. Discuss, With Possible Action, IRUA

Junker explained that the email she received back from Davis Brown Law Firm suggested the Trustees either send another letter demanding that the IRUA ceases violating the permits, similar to what was done in 2018, or file a lawsuit.

Gallentine explained that he had read in the paper that IRUA was applying for a grant to expand their system between Buckeye and Hamilton County. He said he would forward the notice to the Trustees. Junker clarified that currently, the funds for this matter are coming out of the Trustee's account and not being billed to any drainage districts. McClellan said that this is the kind of charge that will need to be sent out to all districts in the future.

Granzow suggested sending a reminder that this issue has not been settled and that there needs to be a meeting with both the Trustees, IRUA and the attorneys. He said that IRUA had agreed in contract to the original permit and that the going backwards needs to get resolved so that in the future, everyone can work together.

Granzow moved, Hoffman seconded to have Davis Brown Law Firm send a letter to IRUA to remind them that this issue has not been settled. The letter needs to request a date for a meeting for all parties involved to sit down and come to a conclusion. All ayes. Motion carried.

7. Discuss, With Possible Action, Open Ditch Bid Letting

Junker explained she has had multiple people come in and ask what needs to be included in the bid they need to be submitting. She explained that currently there is a three year contact that is going to be up and open for bid in December. Hoffman suggested bringing the bid letting to the next meeting to verify and possibly act on and get ready for publication.

8. Other Business

DD 109: Denny Prochaska explained the work that was done in his field. He further explained that he thought the tile his tenant was working on was private tile, not district. After the Trustees heard what was done, they explained that in the future Prochaska needs to check with the drainage clerk to make sure that the tile he is working on within a drainage district is not district tile. Hoffman moved, Granzow seconded to reimburse and pay Denny a total amount \$2953.11. He is willing to do this as long as there is follow through to get the trees taken care of. All ayes. Motion carried.

Granzow then expressed concern about the willow trees that are near the tile. Hoffman moved, Granzow seconded to instruct CGA to investigate what trees and brush needs to be removed and contact Adam Seward with a new work order. All ayes. Motion carried.

9. Adjourn Meeting

Hoffman moved, Granzow seconded to adjourn the meeting. All ayes. Motion carried.

REGULAR DRAINAGE MEETING

9/27/2019 - Minutes

1. Open Meeting

Hardin County Drainage District Board of Trustee Chairperson, Renee McClellan, opened the meeting. Also present was Trustee, BJ Hoffman; Landowners, Kevin Torgeson, Brent Torgeson, Alvin Clark, David Fincham, Larry Otta, Jason Martin, Pam Skartvedt, Denny Friest, Denny Beckman, Robert Lee, Dennis Neubauer, Richard Hebron, Kevin Nessa; Contractor Steve McDowell with McDowell and Sons; Lee Gallentine with Clapsaddle-Garber Associates (CGA); Drainage Clerk, Becca Junker. Trustee Lance Granzow was present via phone.

2. Approve Agenda

Hoffman moved, McClellan seconded to approve the agenda as presented. All ayes. Motion carried.

3. Introductions/Attendance

Introductions were made and attendance verified.

4. Explanation Of Project

The meeting was turned over to Gallentine who explained that while investigating and doing construction, two tile lines were found. He had presented the week before to the Trustees these findings and they decided it was necessary to share these findings with landowners to get their opinions on how to move forward. He explained that one is shallower and is private, the other is deeper and is district. He further explained that the district tile has a large cavity/void missing above the tile and there are a couple small sink holes developing. It is 1-1/2 full of mud and flowing water. There is still a reason to fix the district tile, however to repair the tile they will need to offset the new district tile so that it does not destroy the private tile. The downside of doing that is some of the private tile that is connected to the district tile might not be reconnected because they will not know about it.

In the previous meeting when Gallentine had presented this information Granzow proposed putting a larger tile in instead of having a private tile and a district tile. At that time Gallentine had explained that if they put a bigger tile in under the railroad, they would need to update the railroad permit that had already taken a long time to get approved. With that being said, there is a chance that this project might not get done this year.

The three options that were proposed to the landowners were:

- 1. Proceed per the original plans and offset the drainage district tile from the private tile.
- 2. Proceed per the original plans and offset the drainage district tile from the private tile but install am 18" tile under the railroad.
- 3. Remove the private tile and in return place 18" tile throughout the whole route of the two 10" tiles.

5. Comments/Discussion

Kevin Nessa pointed out that in previous meetings it had been decided to not make improvements on tile going further, so why not get it done and fix what there is and move on. He asked how much it would cost for Engineering Fees, Gallentine responded that it would depend on how much conversation was going to have to be done with the railroad. He explained that it would not cost any extra for Engineering to change from 10" to 18" tile, it will just cost more for the tile itself.

After much conversation it was decided that the landowners did not want to replace the whole length with 18" tile and that they would like a cost estimate before they make a decision.

6. Possible Action

Hoffman moved, Granzow seconded to instruct CGA work in conjunction with McDowell and Son's to get a cost estimate on an 18" crossing and boring and report back to the landowners during a Landowners Meeting on Wednesday, October 9, 2019 at 8:30 AM in the Large Conference Room of the Courthouse. All ayes. Motion carried.

7. Other Business

Gallentine asked the landowners if they wants McDowell and Sons to investigate the private tile to see where it goes beyond what has already been found, it was decided that was not necessary.

8. Adjourn Meeting

Hoffman moved, Granzow seconded adjourn the meeting. All ayes. Motion carried.

All:

I do not believe there is anything especially unique in the drainage district attempting to procure a right of way easement. The code provides that the district is "empowered to construct impounding areas and other flood and erosion control devices to protect lands of the district and drainage structures and may provide ways for access to improvements for the operation or protection thereof, where the cost is not excessive in consideration of the value to the district." This is a fairly low standard, and which appears to be met by the district's current need.

Obtaining the ROW can be done by purchase, lease, or eminent domain under chapter 6B, and may be acquired in conjunction with any political subdivision (e.g. county). If we are leaving the annexation option behind I think we need to determine whether the easement can be obtained by agreement. Given Sailer's lack of responsiveness, I don't know whether there is reason to be optimistic about that prospect. Eminent domain is another option, but that's a much different matter than annexation under chapter 468 and we would want to recalibrate, and I would want to seek the input of one or two of my partners as well.

MINUTES OPEN DITCH TREE AND BRUSH CONTROL BIDS DECEMBER 21, 2016 11:30 A.M.

Hardin County Supervisor Chairman, Lance Granzow, opened the meeting. Also present were Hardin County Supervisors, Ronn Rickels and Renee McClellan; Board of Supervisor Elect, BJ Hoffman; Contractor, Don Reffer with B & W Control Specialists; Drainage Clerk, Tina Schlemme.

Rickels moved, McClellan seconded to approve the agenda as presented. All ayes. Motion carried.

Schlemme verified the publication notice before McClellan opened the bids.

Joe Harrah bid a total of \$70,700 for all drainage districts, including landowner trustee districts as noted. B & W Control bid a total of \$118,000 for all districts for a three year period.

Discussion was had that B & W's quote was the maximum dollar amount allowed but the actual invoices and amounts paid were substantially less. Reffer stated they use Polaris and Streamline as their main chemicals, where Harrah's were Stocker and Streamline as detailed in their brochure. Reffer also added that if chemicals are sprayed in the water that they need to be aquatic herbicides. Insurance requirements were discussed. Reffer stated he has a \$2,000,000 general liability with a \$1,000,000 umbrella plus workers compensation and \$100,000 rider for pollution. Reffer further added that he has 34 years of experience in this industry and has worked for Hardin County since the early 1990's.

McClellan moved, Rickels seconded to table any action on the bids until they are reviewed and additional information is received. The Trustees agreed that Schlemme should submit a summary of the previous amounts bid with actual costs, as well as, obtaining Harrah's insurance and bid details. All ayes. Motion carried.

McClellan moved, Rickels seconded to adjourn the meeting. All ayes. Motion carried.
