- a) Hubbard Tower Update-Nick Whitmore presented update on changes made to Hubbard Tower. The tower will be of type II, which is a little lighter. This requires less foundation and concrete. There will not be room for rented space on this tower, but no one had responded that they wanted to rent space when asked. This project should be complete by mid-November 2019.
- b) Nick advised that there is still question on whether there needs to be fence or just remove climbing rings when complete. Question of Liability from ICAP Carrier or the property owner's insurance carrier. He will continue to gather that information. There will not need to be a separate equipment building as the equipment is small and can be mounted directly on the tower structure.

New Business:

- a) The ISICS Radios have been installed in both Iowa Falls Comm and Hardin County Comm. These will be tested within the next week. Wade Harken advised State radio manager form Cedar Falls/Cedar Rapids radio will be coming to do specific training in the new system and its uses.
- b) Wade Advised that the Iowa E911 report is due to State E911 by January 1, 2020. Will be working with Thomas, Nick to complete for Iowa Falls and Hardin County PSAP's.
