- a) Cots to replace broken-action-Thomas reported that cots have been brought back from Ellsworth College from their Dorm Fire. There were 15 damaged. The cost to replace these 15 cots is \$2600. Item C in Agenda was also discussed. Motion by Renee McClellan to bill Ellsworth College for the costs, wait for the reimbursement then purchase the 15 cots to replace those broken. Seconded by Andrew Clemons Sr. Motion passed unanimously.
- b) Theisen Charge Account-action-There had been a charge account at Theisen's that was closed due to non-use since 2007. Motion by Blake Ritchie to approve Thomas to open this Charge Account again with purchase limits of \$2000.00. Seconded by Scott Williams. Motion passed unanimously.
- c) Bill Ellsworth College for costs of replacements items-discussed above n Item A.

Old Business:

a) EOC Upgrades – Acoustic issues-discuss and possible action-Thomas reported that he had been in contact with an Acoustic Engineer that would cost \$3000 to come in study the sound quality and they would then be able to recommend the type, kind and placement of acoustical material. They stated this would give us a complete package to get acoustics correct the first time in placement. Thomas is to get back to them and get information on guarantees and references. Also, to

- a) 5 Year Strategic Plan Discussion-Possible Action-Discussion on 5year plan and request for any changes. This will be sent out to Commission members again.
- b) FY20-21 Budget Discussion-Discussion on items in the FY 20-21 budget. Salary increase is figured at Cost of living of 1.3% per Board of Supervisors and Merit at 3% per discussion. The items were the capitol of purchasing new tables and chairs for facility, putting \$5000 into Disaster Recovery and Sustenance. There was consensus in the proposed budget and Thomas will put this into the Department of Management forms and have ready for January meeting to approve, publish and set Public Hearing for.

Coordinator Update: Thomas reported that there are two FEMA classes scheduled for the EOC, Training Facility, Sheriff's Department has a training scheduled. There will be more classes and exercises coming as we move through 2020.

Thomas has set up HazMat Refresher for County March 3 at Center. Also, County Fire has requested Thomas setup and organize a Firefighter I class for county. Thomas will assist with teaching, but other instructors will also be teaching. This will Start in January of 2020.
