#### HARDIN COUNTY BOARD OF SUPERVISORS MINUTES – JUNE 23, 2021 WEDNESDAY - 9:00 A.M. COURTHOUSE LARGE CONFERENCE ROOM

Chair BJ Hoffman called the meeting to order. Also present were Supervisors Reneé McClellan and Lance Granzow; and Michael Pearce, Lori Kadner, Thomas Craighton, Taylor Roll, Darrell Meyer, Lee Gallentine, and Angela Silvey. Attending via Zoom: Carey Callaway, JD Holmes, Justin Ites, Dave McDaniel, Cheryl Lawrence, Elaine Loring, Julie Duhn, Lisa Lawler, Curt Groen, Rocky Reents, Jessica Sheridan, Tifani Eisentrager, Megan Harrell, Pauline Lloyd, and Laura Cunningham.

The Pledge of Allegiance was recited.

McClellan moved, Granzow seconded to approve the agenda as posted. Motion carried.

Granzow moved, McClellan seconded to approve the minutes of June 16, 2021 and June 21, 2021. Motion carried.

McClellan moved, Granzow seconded to approve the June 23, 2021 claims for payment. Motion carried.

Emergency Management Update:

Emergency Management Coordinator Thomas Craighton advised a text message that went out to Hardin County Alerts subscribers was legitimate.

Utility Permits: None.

Secondary Roads:

County Engineer Taylor Roll updated the Board on paving and bridge projects. In addition, Roll and Hoffman reminded the public that Iowa Code prohibits the mowing and baling of roadside vegetation prior to July 15.

Public Comments: Julie Duhn requested to be able to comment during a discussion appearing later on the agenda.

Questions and comments were received from Pauline Lloyd.

Discussion was held on return of in-person public attendance at meetings. Craighton recommended implementing a badge system, administered by Security, which would allow 17 people in the Large Conference Room, the maximum occupancy allowed per fire safety guidelines. Duhn and Lloyd provided input. It was decided that Craighton will reevaluate meeting room space, and the Board will act on new in-person attendance guidelines at its June 30, 2021 meeting.

McClellan moved, Granzow seconded to approve the application for fireworks permit submitted by Gehrke's Lake and Campground, for July 3, 2021, at 19747 205th Street, Iowa Falls. Hoffman noted that if the county is under a burn ban on the date of the fireworks display, the permit is void. Motion carried.

Granzow moved, McClellan seconded to approve the Timbers Edge Wedding & Event Center Liquor License Application for Class C Liquor, for a term of 12 months, effective 06/20/2021. Motion carried.

Granzow moved, McClellan seconded to approve the pay increase of Christopher Klein, Assistant County Attorney, to \$74,000/year, effective 07/01/2021. Motion carried.

McClellan moved, Granzow seconded to approve the pay increase of Carol Fletcher, Attorney's Office Manager, to \$42,280/year, effective 07/01/2021. Motion carried.

Granzow moved, McClellan seconded to approve the pay increase of Cliff Cory, Paralegal, to \$46,148/year, effective 07/01/2021. Motion carried.

McClellan moved, Granzow seconded to approve the hiring of Justin Goedken, Roadside Vegetation Specialist, at a rate of \$21.00/hour, effective 07/12/2021. Goedken is eligible for \$0.25/hour raise after completing a 6-month probationary period. Motion carried.

# Item A - Narrative

The proposed project is to surface another 2 miles of the Iowa River's Edge Trail from Highway 175 in Eldora to 260<sup>th</sup> Street just north of Gifford. The site, which has already been secured, is a past railroad corridor -- an excellent trail location never exceeding a 5% grade. The corridor is completely separate from roadways, making it scenic and safe for trail users. The funding requested will be used for preliminary engineering, construction engineering, and the construction of a concrete trail. This project will be a part of the Iowa River's Edge Trail, a 34-mile corridor running from Steamboat Rock to Marshalltown, connecting two counties and the communities of Steamboat Rock, Eldora, Gifford, Union, Marshalltown, Liscomb, and Albion.

Hardin County requests \$300,000 in funding from SRT to pave an additional 2 miles of the Iowa River's Edge Trail from Eldora to 260<sup>th</sup> street just north of Gifford. The project is ready to go if awarded funding. Paving of the proposed 2 miles is a continuation of a segment that is scheduled to begin in 2021. We are confident the design and permitting work will be similar to the current project, which will keep additional engineering needs to a minimum.

# Item B – Narrative

# **1.** Define the need for the project in terms of the population to be served and existing trails in the area. (25 points)

The proposed 2-mile paving project will cut through the heart of Eldora, a bustling small town adjacent to the Iowa River and home to 2,645 people. Eldora is one of the largest towns in the area and is home to a variety of valuable amenities that have made this small community an important central hub for recreation, education, and shopping. Communities in the surrounding area come to Eldora to pick up their groceries, take their children to the aquatic center, and watch movies at the Eldora Grand Theater. This trail segment will be within mere blocks of these amenities, letting Eldora community members and visitors enjoy what Eldora has to offer on foot or by bike.

The construction of an additional 2 miles of the Iowa River's Edge Trail from Eldora to Gifford is a central building block in the endeavor to connect a collection small towns in Central Iowa. The proposed phase expands on the strategy to open sections of trail where residents and tourists have the greatest opportunity to use the trail immediately. Eventually, the Iowa River's Edge Trail will connect to Marshalltown, a large, centrally located, regional destination that is highlighted by many Iowa tourism companies.

As of now, 2 bridges and 3.2 miles of paved trail have been constructed from Steamboat Rock south toward Eldora, and additional funding has been secured to pave another 4.4 miles of the trail to Hwy 175 in Eldora. Construction is also anticipated on 7 more bridges from Eldora toward Gifford in 2022, making a continuous corridor from Steamboat Rock to the South Fork of the Iowa River. This project will pave an additional 2 miles, bringing the portion of the Iowa River's Edge Trail in Hardin County closer to completion with more than half of their 19 miles of trails paved. The remaining corridor to be paved in Hardin County will be phased into manageable segments, connecting communities and landmarks.

Paving of the Iowa River's Edge Trail also works to close a gap in the Great American Rail Trail and the American Discovery Trail. Both of these nationally significant trail corridors incorporate the Iowa River's Edge Trail into their routes. The Great American Rail Trail is the newest of the nationally significant efforts being constructed and is being supported by the Rails to Trails Conservancy (RTC). RTC has been a vocal champion for the Iowa River's Edge Trail, helping to identify private funding opportunities and supporting the trail committee's application for a Federal Transportation and Infrastructure Member Designated Project.

#### 2. Describe the compatibility with local, area-wide, regional, or statewide plans. (15 points)

Multiple state, local, and regional plans support the ongoing vison of the Iowa River's Edge Trail. The result is the political and social support of thousands of Iowans in the region. Below are planning documents which support the continued funding of this project.

Eldora Comprehensive Plan

The Iowa River's Edge Trail is a key element in promoting regional tourism that has been supported by the City of Eldora for over 30 years. In 2012, citizens and leaders of Eldora came together to develop the Eldora Comprehensive Plan, which stresses the following goals:

- Keep up promoting access to natural areas: Project organizers have developed promotional materials and an online presence with a web page and Facebook posts to raise awareness of the project and promote outdoor recreation.
- Connecting trails should be a priority to encourage tourism: The submitted project of the Iowa River's Edge Trail will link to the Eldora Community Trail and the Pine Lake Trail creating a 10-mile loop. Such a connection will attract more users to the area, ultimately increasing tourism.
- Make vacation industry a part of the economy: The combination of the above two recommendations accomplished by the Iowa River Trail will inevitably lead to growing the vacation industry in this region's economy.

#### Hardin County Comprehensive Plan

The Comprehensive Plan outlines goals for Hardin County to meet in the foreseeable future, and specifically calls for securing the Iowa River Railroad and transforming it into a rail trail. That rail trail is the proposed Iowa River's Edge Trail and is seen by the Plan as a strong economic and recreational opportunity for communities in Hardin County.

"Iowa River Railroad – should rail bank the part that is being abandoned for future rail use and build a rail trail that could be extended to connect with Ackley – would be good economic development for the County and the nearby communities."

#### Iowa Statewide Comprehensive Outdoor Recreation Plan (SCORP):

The 2018 Statewide Comprehensive Outdoor Recreation Plan (SCORP) produced by the DNR lists 5year priorities for natural resource, parks and outdoor recreation. The #1 priority is the availability and diversity of natural resources, parks and outdoor recreation opportunities that enhance the quality of life of Iowans. The Iowa River's Edge Trail offers a unique downtown walking experience that will easily connect people with nature outside of Eldora.

#### Region 6 Comprehensive Economic Development Strategy

The Region 6 Planning Commission has combined strategic planning efforts with local businesses and economic development personnel to create a Comprehensive Economic Development Strategy (CEDS). Preservation of the railroad corridor for trail purposes is specifically mentioned in the Region 6 Development Initiative. This expansion of the Iowa River's Edge Trail will help with the CEDS's five main goals, as trails are shown to promote small and locally-owned businesses, healthy lifestyles, environmental quality, housing quality, and diverse community attractions.

#### Iowa Bicycle and Pedestrian Long Range Plan

In December 2018, when the DOT published their Iowa Bicycle and Pedestrian Long Range Plan, there were 1,990 miles of existing trail in Iowa and 3,047 miles of proposed trail. This shows the desire of Iowans to substantially increase trail mileage. The Iowa River's Edge Trail extension will pass by

WinField United, an agricultural products manufacturer, giving Eldora employees an opportunity to commute to work on bike. Once complete, the Iowa River's Edge Trail will add an additional 34 miles to the existing state trails.

#### Great American Rail Trail

In May 2019, the Rail-to-Trails Conservancy announced the 3,700-mile Great American Rail Trail (GART). GART is a national goal to create a cross-county trail stretching from Washington, D.C. to Washington State. The Iowa River Trail is included in the GART route, providing 32 necessary miles for this cross-county connection. This phase of the project will add 2 miles to the GART route, getting one step closer to connecting the United States from coast-to-coast.

#### 3. Describe the benefits of multiple uses and recreational opportunities. (20 points)

The 34-mile Iowa River's Edge Trail travels through the Iowa River Greenbelt, an area known as a recreation destination for all kinds of outdoor enthusiasts. Trail advocates know the importance of continuing this inclusivity as they design and construct the corridor. The connection between Eldora and Gifford will give both populations an opportunity to travel between one another in a way that is safe and enjoyable, linking together neighboring small towns in a way that offers a different method of travel and entertainment.

**Hiking**: Passing through the city of Eldora, this trail provides an attractive route for casual hikers of all ages. The second half of this phase is treelined, which offers opportunities for birders and nature enthusiasts to encounter Iowa wildlife while they enjoy the trail.

**Fat Tire Biking/Mountain Biking**: These wide-tired bikes will find an adventure traveling over 50% of the undeveloped portions Iowa River's Edge Trail in Hardin County where bridges have been rehabilitated.

**Geocaching**: The Iowa River Trail will become a geocaching hotspot. Geocaching is a very popular activity along the Iowa River Greenbelt. There are already several caches located along the Iowa River's Edge Trail. It is anticipated that this sport will continue to grow with the completion of the trail. Completing this phase and future phases of the trail will increase the chances for people of all physical abilities and experience to participate in geocaching along the Iowa River's Edge Trail.

**Snowmobiling**: A stakeholder in the currently undeveloped trail are the Central Iowa Snowmobilers. This club uses the undeveloped corridor for part of their system. It is the intention of trail managers to not snow plow the corridor in the winter to continue to allow its use by this group.

**Cross-Country Skiing**: Cross-country ski trails are found at Pine Lake State Park, just outside of Eldora. Just like snowmobiles, the unplowed path in the wintertime will create a safe, scenic route for skiers to travel.

**River Tubing**: The proposed section of the trail will connect Gifford to the larger trail loop which passes right by the Rock-n-Row Adventures River Tubing. Trail users can hop off the path and enjoy floating down the Iowa River to beat the heat during the summer.

#### **4.** Define the quality of the site. (25 points)

It is the goal of the managing trail entities to maintain the corridor outside of city boundaries as a linear wildlife corridor. To that end, a botanical survey was conducted in 2019 along the entire trail, which revealed a variety of threatened species in the area. This inventory helped to create a management plan which has better allowed the stewardship of the right-of-way for prairie and habitat restoration. Annually, a local contractor has been hired for vegetation management of the developed and undeveloped areas. Not only does this start the work to create an enjoyable scenic experience for the user, but this also ensures that the corridor does not become overgrown before development.

This segment will connect downtown Eldora to the section of the trail that runs along the Iowa River Greenbelt, a scenic 42-mile stretch of river valley stretching from Alden to Union. The Iowa River Greenbelt offers diverse wildlife habitats, numerous recreational opportunities, and picturesque views. Environmentally, the expansion of this trail will help protect the greenbelt, in turn protecting the variety of rare and endangered plants and animals that call the Iowa River Greenbelt their home.

#### **5.** Describe the economic benefits to the local area. (10 points)

Eldora is home to many local businesses, museums, lodging facilities, and tourist attractions. This proposed trail extension will increase foot traffic in Eldora, in turn increasing the economy of Eldora's local businesses. The Hardin County Fair is a big attraction every summer, and the fairgrounds are in the heart of Eldora. This trail expansion project will draw even more people to Eldora for the fair, increasing business in and around the fairgrounds.

With the new trail extension, Eldora will be an attractive location for people to hop off the Iowa River's Edge Trail and settle in for a long stay in the city. Eldora has a few lodging facilities, including the Indleside Bed & Breakfast, Eldora Motel, and the White House of Eldora. All these places to are locally owned, allowing overnight trail users to support local businesses while enjoying the exciting attractions the city has to offer. Also, Pine Lake State Park has cabins, campsites, and Airbnb locations for trail users who wish to stay in the park.

For the day-tripping trail users, there are plenty of local attractions, including Eldora's Railroad Museum and the Rock-n-Row Adventures river tubing and camping company. This trail expansion will increase business for Rock-n-Row Adventures, as many trail users seek outdoor adventure. Overall, the extension of the Iowa River's Edge Trail to Eldora will greatly benefit the local economy in the area.

#### 6. Describe any special facilities for disabled users. (5 points)

Hardin County understands the need to provide quality of life amenities that not only attract and retain families to its rural communities, but also create recreational opportunities that all of its residents can enjoy. The Iowa River's Edge Trail will be free to the public and open to all ages, backgrounds, and abilities. The trail may be an especially valuable resource for older and disabled Iowans, as the gentle slope of the existing rail grade does not exceed 5%, making it an easily accessible amenity for transportation and outdoor recreation.

Managing agencies will further ensure the trail is available for appropriate other power-driven mobility devices and meet all ADA requirements. When fully completed, the 10-foot-wide concrete path will allow for easy and spacious wheelchair use. The parallel 5-foot soft path will accommodate faster users such as runners who do not wish to use the paved trail. Benches along the trail will provide relief for elderly and disabled trail users who could use a break; this is especially important in Eldora where more than 25% of the population is over the age of 60.

#### 7. Project "shovel readiness." (25 points)

The Hardin County Trails Commission received a 2018 Federal Recreational Trails grant for \$425,000 to complete paving and prepping of 2.5 miles of trail from Steamboat Rock to 215<sup>th</sup> Street north of Eldora. Another \$375,000 State Recreational Trails grant request was accepted in 2019 that was used to continue this paving project, extending the trail from Edgington Ave in Eldora. That segment of the trail is currently in the early stages of the construction process.

The Iowa River's Edge Trail has already commenced its initial trail paving, having completed a onemile segment of trail near Steamboat Rock. The initial stretch of trail that was paved near Steamboat Rock was completed in the summer of 2018 and came in under budget by \$125,000. We are confident that we would be able to start this proposed trail expansion and finish within two years.

The Hardin County Trails Commission has already selected Snyder & Associates to be the engineering firm for these phases of the trail extension project. Designs to extend the trail to Hwy 175/Edgington Ave are already complete. Those plans would merely have to be updated to include the additional 2 miles of proposed work along a similar type of terrain on the same former rail corridor without additional structures. The project is shovel ready, and work can begin as early as soon as funding is awarded. **Receiving this \$300,000 State Recreational Trails grant would be the final step before beginning construction on this phase of the Iowa River's Edge Trail.** 

#### 8. Local funding for the project. (5 points)

It is important to note that while this application does not have as much secured local funding as others, the ongoing work of the Iowa River's Edge Trail has leveraged significant contributions from the private sector. Roughly \$4,000 of local funds from the city of Eldora will be used for wayfinding signage along this portion of the trail and the previous phases. Additionally, nearly \$300,000 of local and private funding has been secured and directed to the reconstruction of the bridge over the South Fork of the Iowa River and two other bridges within Hardin County (Phase 3). These are the next three bridges of the phased trail work with a total project cost of nearly \$2 million. Additionally, over \$250,000 of local funding has been raised to help with previous phases of the Iowa River's Edge Trail. A COVID-19 Relief application was submitted for this phase of the project. Additional state, federal, foundation, and private funding is already being sought to match this request in case COVID dollars are unavailable.

Budget was determined based on recent bids received on similar projects and using the average design and construction engineering costs found in the application packet. Construction costs also mirror the typical cost per miles of rolling terrain found in the State Bicycle and Pedestrian Plan. We have found with previous paving projects along the River's Edge Trail that it is more appropriate to use this estimate than a typical former railroad corridor due to the nature of the right-of-way traversing the Iowa River Greenbelt. While the total project cost is \$1,000,000, we are planning to submit \$2,000,000 in funding requests in case we do not receive COVID-19 Relief Funds.

## Item J – Adjacent Property Owners Narrative

The Iowa River's Edge Trail has been an evolving project for more than eight years as evidenced in the Marshalltown Times-Republican's first published article in March of 2011. The news story covered the series of events that took place up to and at the Iowa Department of Transportation's public meeting in Eldora. Many interested landowners and businesses serviced by the rail attended to learn more about the impending Iowa River Railroad abandonment and what it meant for them. Community members and local leaders voiced interest in a trail if rail service was no longer a viable option.

In early spring of 2012, a large group of individuals representing city councils, county supervisors, cycling clubs, economic development corporations, businesses, healthcare industries, and many who were in attendance at the IDOT meeting the year before, gathered again. The Iowa River Railroad had officially filed to discontinue rail service along the corridor. Those attending the meeting were discussing the next steps for the right-of-way and whether a trail would be a good fit.

By the summer of 2012, staff from Iowa Natural Heritage Foundation (INHF) had presented information to the Marshall County Supervisors at a formal supervisor's meeting as well as meeting with them and representatives from Marshall County Conservation Board, Liscomb, Albion, and Marshalltown in a more formal public meeting atmosphere. INHF staff had also met by that time with Hardin County Supervisors, Hardin County Conservation Board, Union, Eldora, and Steamboat Rock to share more detailed information and to gauge community/public support for the project- and whether to proceed with acquisition. In May of 2012 all jurisdictions had agreed to file for a Notice of Interim Trail Use for the corridor.

Community meetings were held in both Marshall and Hardin County throughout 2013. Nearly each meeting has been chronicled by the Times-Republican making even those that did not attend aware of the on-going trail planning. The Times-Republican's editorial entitled, "Consider the benefits of developing a recreational trail," or the two additional letters to the editor, "City council should vote yes to support the trail," and "Major investments prove value over time," are just some indicators of the acceptance and support the Iowa River Trail has been receiving.

In February of 2014, the Hardin County Board of Supervisors officially established a County Trails Commission. The commission oversees the 22-mile segment of the future Iowa River Trail in Hardin County. They are tasked with a variety of duties that are vital to the continued development of the Iowa River Trail: fundraising, project planning, development of rules and regulations, management and maintenance, etc.

The County Trails Commission meets bimonthly with TRAILS, Inc (Marshalltown/Marshall County's mirroring collaboration) to create what is known as the Joint Committee. The Joint Committee meetings are open to the public. Minutes of the meeting are posted and shared with each jurisdiction along the Iowa River Trail.

To date, there have been minimal concerns raised by adjacent landowners, and any concerns brought to us were immediately addressed.

#### RESOLUTION FOR INTER-FUND OPERATING TRANSFERS 2021/2022 FISCAL YEAR

WHEREAS, it is desired to authorize the Auditor to periodically transfer sums from the General Basic Fund to the Capital Projects Fund and Secondary Road Fund; and from the Rural Services Basic Fund to the Secondary Road Fund during the 2021/2022 fiscal budget year, and

WHEREAS, said transfers must be in accordance with Section 331.432, Code of Iowa,

Section 2. When notified of the apportionment of current property taxes, state replacements against levied property taxes, mobile home taxes, military service tax credit replacements, or livestock credit replacements to the General Basic or Rural Services Basic funds, the Auditor shall order a transfer from said fund to the Secondary Road Fund.

Section 3. The amount of the transfer required by Section 2 shall be equal to the apportionment made under Section 2 to the General Basic or Rural Basic Fund, respectively, multiplied by the ratio of said fund's total maximum transfer to the Secondary Road Fund, to the sum of said fund's total current property tax levy, total mobile home taxes, total military service tax credit replacements and total livestock credit replacements.

Section 4. Notwithstanding the provisions of Sections 2 and 3 of this resolution, total transfers to the above mentioned funds shall not exceed the amount specified in Section 1.

Section 5. Notwithstanding the provisions of Sections 2 and 3, the amount of any transfer shall not exceed available fund balances in the transferring fund.

Section 6. The Auditor is directed to correct her books when said operating transfers are made and to notify the Treasurer and County Engineer of the amounts of said transfers.

I hope you will consider my increased responsibilities and duties with the CICS expansion and recognize the need to keep my salary in line and commensurate with the other Administrative Team members in reviewing this request. Here are some points I hope you will consider:

- 95% of my salary is covered by the CICS region.
- The requested amount was included and approved in the budget by both your Board and the CICS region.
- The CICS Governing Board had previously recommended adjustments based on the increased responsibilities of the Administrative Team with the addition of 4 new counties.
- With the CICS expansion on 7/1/21 my duties will be expanded to include 4 additional counties, for a total of 15 counties, and supervising 4 additional Service Coordination staff. I will be supervising a total of 21 staff (CICS and local staff).
- The CICS administrative costs for functions performed by our Administrative/Management Team, even with requested adjustments, remains less than most regions.
