WHEREAS, a new truck storage building is needed to replace the current, failing structure at the Eldora Secondary Roads Maintenance Shop located at 409 17th Street, Eldora, Iowa.

WHEREAS, the estimated cost of construction exceeds the competitive bid threshold set by the State of Iowa.

WHEREAS, a public hearing is required according to Iowa Code 26.12 to approve the plans, specifications, form of contract, and estimated total cost of the public improvement.

NOW, THEREFORE BE IT RESOLVED that a hearing on the proposed building construction will be held at the Hardin County Courthouse, Eldora, Iowa, 50627 at 9:02 a.m. on February 26th, 2024, in accordance with Iowa Code Chapter 306.
