HARDIN COUNTY COURTHOUSE LARGE CONFERENCE ROOM

The Hardin County Board of Supervisors held their regular meeting at 9:00 AM on May 13, 2024, at the Hardin County Courthouse Large Conference Room in Eldora, Iowa.

McClellan moved and Hoffman seconded the motion to approve the agenda. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to approve the minutes of May 06, 2024 & 07, 2024. All Ayes. Motion carried.

McClellan moved and Hoffman seconded the motion to approve claims for payment for May 13, 2024. All Ayes. Motion carried.

Hoffman moved and McClellan seconded the motion to approve the appointment of the Auditor’s Office to update policies and procedures. All Ayes. Motion carried.

McClellan moved and Hoffman seconded the motion to approve the Special Class F Retail Alcohol License for Iowa Falls Moose Lodge. Discussion: Hoffman stated that this was affective May 1, 2024, and expires April 30, 2025. All Ayes. Motion carried.

Other Business: Hardin County Engineer Taylor Roll along with two of his employees, Mark Oliver and Marty Eide explained the job duties, responsibilities, and purpose involved in Secondary Road work. Roll explained the reasoning behind the steps that need to be taken to restore driving surfaces and draining attributes to roads. Roll also explained the financial aspect involved in restoring and upkeep of road conditions.

Public Comments: Lloyd also stated her opinion on work that had been on 290<sup>th</sup> St. Roger Sutton also stated his opinion and thanked Roll for his presentation to help him understand road work. Hoffman stated that he wanted to do a curtesy. Hoffman stated that he had heard that there was a new motion picture coming out and he just wanted to ask the public to respect the Juber's by not trespassing on their property.

McClellan moved and Hoffman seconded the motion to adjourn. All Ayes. Motion carried.
