Notice is hereby given to the qualified voters of Hardin County, Iowa, that the 2024 General Election will be held on Tuesday, November 5, 2024. A public test of the vote tabulating equipment will be conducted in the Large Conference Room at the Hardin County Courthouse beginning on November 5, 2024 at 9:00 a.m. and continuing until completion of the required test.

Hardin County residents who are not registered to vote are encouraged to do so. Residents may register in the office of the County Auditor in person, may obtain a registration form online at [www.hardincountyiowa.gov](http://www.hardincountyiowa.gov), may request that a registration form be mailed to them, or may register online at [www.sos.ia.gov](http://www.sos.ia.gov). The deadline to pre-register to vote for this election is October 21, 2024. With appropriate identification, an eligible elector may also register to vote on Election Day in the precinct where the person lives.

Voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered or who have changed precincts are also required to provide proof of residence.

Any voter who cannot show ID may: 1) have voter’s identity/residence attested to by another registered voter in the precinct; 2) prove identity and residence using Election Day Registration documents; or 3) cast a provisional ballot and provide proof of identity/residence at the County Auditor’s office by noon on November 12, 2024. Voter Accessibility: All voting sites are fully accessible to persons with physical disabilities. Voters may choose another person to assist them to vote, except their employer, employer's agent, or an officer or agent of the voter's union.

Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle.

**CONSTITUTIONAL AMENDMENT 1**

SHALL THE FOLLING AMENDMENT TO THE CONSTITUTION BE ADOPTED?

(VOTE YES OR NO)

Shall the following amendment to the Constitution be adopted? 1 Summary: Provides for only U.S. citizens aged 18 or older and meeting state and county residency requirements to vote in all elections. Further provides that 17-year-olds who will be 18 years old by the General Election are eligible to vote in the primary election, subject to the same citizenship and residency requirements. Full Text: Section 1 of Article II of the Constitution of the State of Iowa, as amended by the amendment of 1970, is repealed and the following adopted in lieu thereof: Section 1. Electors. Only a citizen of the United States of the age of eighteen years, who shall have been a resident of this state for such period of time as shall be provided by law and of the county in which the citizen claims the citizen's vote for such period of time as shall be provided by law, shall be entitled to vote at all elections which are authorized by law. However, for

purposes of a primary election, a United States citizen must be at least eighteen years of age as of the next general election following the primary election. The required periods of residence shall not exceed six months in this state and sixty days in the county.

**CONSTITUTIONAL AMENDMENT 2**

SHALL THE FOLLING AMENDMENT TO THE CONSTITUTION BE ADOPTED?

(VOTE YES OR NO)

Summary: Provides that the lieutenant governor will act as the governor if there is a temporary disability of the governor. Further provides that the lieutenant governor or lieutenant governor-elect will be the governor or governor-elect in the case of the resignation, death, or permanent disability of the governor or governor-elect thus creating a vacancy in the office of lieutenant governor or lieutenant governor-elect, as appropriate. Full Text: Section 17 of Article IV of the Constitution of the State of Iowa is repealed and the following adopted in lieu thereof: Sec. 17. Lieutenant governor or lieutenant governor-elect to become or act as governor or governor-elect. If there is a temporary disability of the governor, the lieutenant governor shall act as governor until the disability is removed, or the governor dies, resigns, or is removed from office. In case of the death, resignation, or removal from office of the governor, the lieutenant governor shall become governor for the remainder of the term, which shall create a vacancy in the office of lieutenant governor. This section shall also apply, as appropriate, to the governor-elect and the lieutenant governor-elect.

**PUBLIC MEASURE IQ (FOR AGWSR SCHOOL DISTRICT ONLY)**

(VOTE YES OR NO)

Shall the Board of Directors of the AGWSR Community School District in the Counties of Butler, Franklin, Grundy and Hardin, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$14,450,000 to provide funds to remodel, repair and improve the existing High School building, including HVAC, mechanical, electrical and window improvements; to build, furnish and equip new bus barns; to remodel, repair, and improve the existing middle school, including tuck pointing; and site improvements at the Wellsburg Center campus, including parking lot drainage improvements?

**PUBLIC MEASURE JS (FOR UNINCORPORATED AREAS IN HARDIN COUNTY ONLY)**

(VOTE YES OR NO)

“Shall Hardin County, Iowa be authorized to impose a Local Hotel and Motel Tax at the rate of seven percent (7%) effective January 1, 2025, with at least fifty percent (50%) of the revenues derived from the Local Hotel and Motel Tax to be used for acquisition of sites for, or constructing, improving, enlarging, equipping, repairing, operating, or maintaining of recreation, convention, cultural, or entertainment facilities including but not limited to memorial buildings, halls and monuments, civic center convention buildings, auditoriums, coliseums, and parking areas or facilities located at those recreation, convention, cultural, or entertainment facilities or the payment of principal and interest, when due, on bonds or other evidence of indebtedness issued by the county or city for those recreation, convention, cultural, or entertainment facilities; or for the promotion and encouragement of tourist and convention business in the city or county and surrounding areas; and the remaining revenues derived from the Local Hotel and Motel Tax to be used for all other purposes permitted by Chapter 423A of the Code of Iowa?”
